A motion was made by Moss and seconded by Shimanek to approve #24 Authorizing Reduced Speed Limit County Road NS 2855 from EW800, South (1mile) to EW 810, from 45mph to 35 mph in accordance with O.S. 47 § 11-801 (F)(1) because of substantial growth and school bus routes.
