They did not go with the lowest bid which was Vance Brothers because (1) material issues — Failure of chips adhering & excessive bleeding 2019-2020 (2). Performance of work — 2019-2020 The bid amounts are as follows on 5/8" single application — Oil CSR-2S @.45 gal/S.Y. 5/8" chips @35lbs/S.Y. Vance Brothers - \$21,038.41 Circle C Paving - \$24,394.23 Blevins - \$25,555.86.
