9. A motion was made by Schwarz and seconded by Moss to approve Monthly reports for Election Board and Court Clerk.

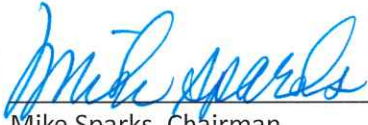
