A RESOLUTION AUTHORIZING THE CALLING AND HOLDING OF A SPECIAL ELECTION ON NOVEMBER 18, 2025, IN KINGFISHER COUNTY, STATE OF OKLAHOMA, FOR THE PURPOSE OF SUBMITTING TO THE REGISTERED AND QUALIFIED ELECTORS THEREOF THE QUESTION OF WHETHER TO APPROVE A ½ CENT (\$0.005) COUNTY SALES TAX FOR COUNTY GENERAL FUND and COMMUNITY SERVICES, BEING LIMITED TO FIVE (5) YEARS, EFFECTIVE ON AND AFTER FEBRUARY 1st, 2026.

WHEREAS, the Board of County Commissioners of Kingfisher County, State of Oklahoma, find that it is in the public best interest to levy a sales tax rate of ½ percent (%) or ½ cent (\$0.005) designated for County General Fund and Community Services for a period of five (5) years to be effective on and after February 1st, 2026, to enhance and improve the safety, security and general wellbeing of the people and businesses of Kingfisher County, Oklahoma with the proceeds of said sales tax to be designated solely for community services and county government and;

WHEREAS, Title 68 of the Oklahoma Statutes, Section 1370, requires that before a sales tax may be levied by the county, the imposition of the tax shall first be approved by a majority of the registered voters of the county voting thereon at a special election called by the Board of County Commissioners; and

WHEREAS, a special election for this question should be held on November 18th, 2025.

NOW, THEREFORE, be it resolved that, the Board of County Commissioners of Kingfisher County, State of Oklahoma, that a special election is hereby called and shall be conducted on November 18th 2025, for the purpose of submitting to the registered and qualified electors of Kingfisher County, State of Oklahoma, the following Proposition:

Shall Kingfisher County, State of Oklahoma, levy, impose and collect sales tax of ½ percent (%) upon the gross proceeds or gross receipts derived from all sales or services within the territorial limits of Kingfisher County, State of Oklahoma, upon which a consumer's sales tax is levied by the State of Oklahoma, for a period of five (5) years from February 1st, 2026, providing exemptions, providing for administration and collection of tax, requiring filing of returns, providing for interest and penalties for failure to pay such tax when due, providing for refund of erroneous payments, requiring taxpayers to keep records and vendors to collect tax from purchasers at the time of sale and establishing liens, making tax cumulative, and defining terms, with the proceeds of said sales tax to be designated solely for the following purposes?
