A RESOLUTION ESTABLISHING ANNUAL NOTICE OF REGULARLY SCHEDULED PUBLIC MEETINGS OF THE KINGFISHER COUNTY EDUCATIONAL FACILITIES AUTHORITY; CONDUCTING AN ANNUAL AUDIT AND APPROVING ANNUAL AUDIT AS NEEDED; REVIEWING AND SELECTING FISCAL YEAR OFFICERS OF THE AUTHORITY AND THE TAKING OF OTHER ACTION WITH RESPECT THERETO.

WHEREAS, pursuant to the Open Meeting Act, 25 O.S., §301 et. Seq., the Authority is required to file an Annual Notice of Regularly Scheduled Public Meetings with the County Clerk's office before December 15, 2026, and

WHEREAS, as required by the bond documents for the bond issuances of the Authority from time to time, the Authority shall conduct an annual audit and submit copies to the trustee bank and the financial advisor for each financing as set forth in the bond documents.

BE IT RESOLVED BY THE TRUSTEES OF THE KINGFISHER COUNTY EDUCATIONAL FACILITIES AUTHORITY:

SECTION 1. The Authority hereby approves the Annual Notice of Regularly Scheduled Public Meetings and will file said annual Notice with the Kingfisher County Clerk before December 15, 2026.

SECTION 2. The Authority authorizes the annual audit and will distribute copies to the trustee bank and financial advisor and any other parties as may be deemed necessary and approve the audit as needed, as set forth in the bond documents.

SECTION 3. The Authority hereby selects Sparks to serve as Chairman, Moss to serve as Vice-Chairman, and Emily Lee to serve as Secretary.

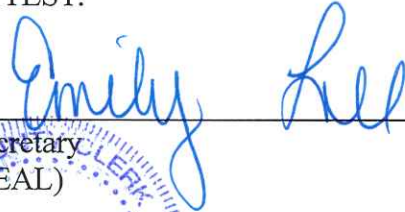

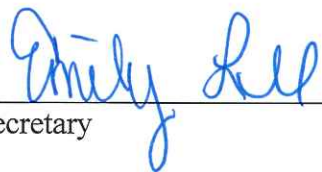

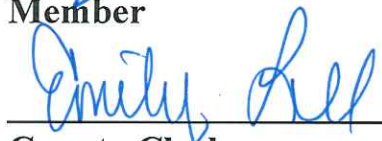
