A RESOLUTION APPROVING AND RENEWING THE SUBLEASE AGREEMENT DATED AUGUST 1, 2019, BY AND BETWEEN THE KINGFISHER COUNTY EDUCATIONAL FACILITIES AUTHORITY (THE "AUTHORITY") AND THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NO. 3 OF KINGFISHER COUNTY, OKLAHOMA (LOMEGA PUBLIC SCHOOLS) (THE "SCHOOL DISTRICT"); AND THE TAKING OF OTHER ACTION WITH RESPECT THERETO.

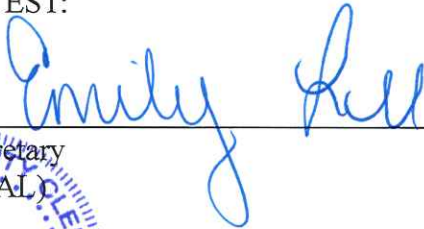

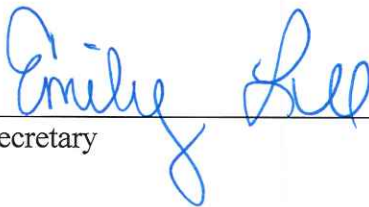
